#### BACKGROUND/RELATED STRATEGIC GOAL:

The Drug and Alcohol Abuse Awareness Committee was created by Resolution No. 87-7.37 on July 28, 1987. Resolution No. 87-7.37 was rescinded in 2019 and again in 2020, and Resolution Nos. 19-11.3 and 20-2.21 were adopted to update the Drug and Alcohol Abuse Awareness Committee including makeup, terms, and change the Circuit Court Judge to a non-voting member. Resolution Nos. 19-11.3 and 20-2.21 are attached. The Drug and Alcohol Abuse Awareness Committee shall serve as an advisory committee to the County Commissioners on issues relating to adult and youth substance and alcohol abuse in Martin County. The Committee will make recommendations on
