BACKGROUND/RELATED STRATEGIC GOAL:

It has been agreed between the municipalities within the County (Town of Sewall's Point, Jupiter Island, City of Stuart, and now the Village of Indiantown) that the municipal appointments to the TCRPC will be done on a three-year rotation schedule.

Primary: City of Stuart

Alternate: Town of Sewall's Point

November 2020 to November 2023 for calendar years 2021-2023

Primary: Town of Sewall's Point

Alternate: Village of Indiantown

November 2023 to November 2026 for calendar years 2024-2026

Primary: Village of Indiantown

Alternate: Town of Jupiter Island

November 2026 to November 2029 for calendar years 2027-2029

Primary: Town of Jupiter Island

Alternate: City of Stuart

November 2029 to November 2032 for calendar years 2030-2032

On December 8, 2020 the Board confirmed the alternate appointment of Vice Mayor James W. Campo, Town of Sewall's Point.
