The position of Fire Chief was initially vacated in October 2020 when then Chief Schobel left his employment via the Voluntary Early Separation Incentive Program (VESIP). Deputy Fire Chief Kevin Herndon was placed into the role of Interim Fire Chief to allow for a smooth transition and the least disruption to operations of the department. Battalion Chief, Chief Chad Cianciulli was placed into the position of Interim Deputy Chief to assist and maintain operations of the department. Chief Herndon recently decided to take advantage of the current VESIP being offered and leave his employment
