EXECUTIVE SUMMARY:

Request approval of a SSLE renewal to continue multimodal access in Port Salerno from SE Railway Avenue to SE Salerno Road. The multimodal access provides an alternative pedestrian and bicycle pathway west of Dixie Highway and allows for mobility without having to cross the railroad.

The County currently has a SSLE with the State of Florida/TITF over certain lands inclusive of the Railway Avenue Pedestrian Bridge over Salerno Creek within the Manatee Creek Basin. These submerged lands are located between SE Railway Avenue, SE Salerno Road, west of SE Dixie Highway over the Salerno Creek outfall in Port Salerno. In 1991, the County received FDEP Permit No. 431976038 and subsequent easement solely for the installation of a pedestrian bridge. This renewal is for the continued operation and maintenance of the pedestrian bridge to provide a multimodal pathway within the Port Salerno Community Redevelopment Area. No additional structures, major appurtenances, or realignment is permitted without consent from the Grantor.
