APPROVAL OF AN INTERLOCAL AGREEMENT BETWEEN THE MARTIN COUNTY BOARD OF COUNTY COMMISSIONERS AND THE TOWN OF JUPITER ISLAND

EXECUTIVE SUMMARY:

The proposed Interlocal Agreement between Martin County and the Town of Jupiter Island provides for highly skilled first responders for the Town to ensure emergency medical services and fire protection support are available to residents, guests, and visitors of the Town on a 24-hour basis. The Agreement commences on October 1, 2022 for a five (5) year term through September 30, 2027.

BACKGROUND/RELATED STRATEGIC GOAL:

1. Agreement drafted by: Martin County and the Town of Jupiter Island

2. Parties to the Agreement: Martin County and the Town of Jupiter Island

3. Purpose of the Agreement: Provide twenty-four (24) hour first responder Advanced Life

Support services and fire protection support to the Town.

- 4. This is a renewal of the Interlocal Agreement.
- 5. Duration: Five (5) years with a five (5) year renewal.
- 6. Benefits to the County: Provide the Town of Jupiter Island with emergency medical services and fire protection support.
- 7. Cost to Martin County: There is no cost to Martin County. The Town will pay the County one (1) million dollars for the first year of the Agreement. Each subsequent year the fee will be increased annually by 3%. The following is a fee schedule for the five (5) year term of this Agreement:

Fiscal Year 2023 - \$1,000,000.00

Fiscal Year 2024 - \$1,030,000.00

Fiscal Year 2025 - \$1,060,900.00

Fiscal Year 2026 - \$1,092,727.00

Fiscal Year 2027 - \$1,125,508.81
