### **BACKGROUND/RELATED STRATEGIC GOAL:**

The Health Facilities Authority was created pursuant to Florida Statute Section 154.207 and Resolution No. 82-2.13. The Authority is a local governmental body created as a public body corporate and politic and constituted as a public instrumentality for the purposes of assisting in the development and maintenance of health facilities and projects as defined in Chapter 154, Part III, Florida Statutes, as amended. The Authority is created and authorized to act for the purpose of financing and refinancing projects as defined in the Health Facilities Authorities Law, Chapter 154, Part III, Florida Statutes, as amended, for the public purposes described in and in the manner provided by the Health Facilities Authorities Law, as amended.

The Authority shall be comprised of five members who are residents and electors of the County. After initial appointment, the term of office for each member shall be for four years. The Health Facilities Authority meets as needed at the Administrative Center.

The Administration Staff advised Dr. Teena-Louise White that her term will expire on April 18, 2019. She was provided an Application for Appointment to complete and return if so desired.

An Information Release soliciting applicants was emailed via Constant Contact to the Outreach Martin and Local Media email lists which includes local Chambers of Commerce, local businesses, local media, and citizens (well over 1,500 recipients). The Information Release was also posted to

the County's web page under News.

The Administration Staff will advise the applicants of the Commission's decision which will include Sunshine Law information. A Chair letter and framed Certificate of Appreciation will be mailed to Dr. White if she is not reappointed. The Chair letter and Certificate will be signed by the Chairman.

## **ISSUES**:

The Board is asked to appoint Teena White (incumbent) or Richard Zurich to the Health Facilities Authority for a four-year term to begin April 19, 2019 and end April 18, 2023. Voting sheet attached.
