BACKGROUND/RELATED STRATEGIC GOAL:

- 1. Agreement/Contract drafted by: Martin County and the School Board of Martin County
- 2. Parties to the Agreement/Contract: Martin County and the School Board of Martin County
- 3. Purpose of the Agreement/Contract: Formalize the coordination of the emergency sheltering program
- 4. New/Renewal/Modification: Modification
- 5. Duration: Five years from the effective date; however, it cannot be terminated between June 1 and November 30 (hurricane season)
- 6. Cost to Martin County (annual and potential): Annual none; Potential school district cost of shelter operations during an emergency

This Agreement also outlines the reimbursement requirements for Martin County to the School Board, which would support the County's needs for FEMA reimbursement, if a presidential disaster declaration is received.
