BACKGROUND/RELATED STRATEGIC GOAL:

Martin County is considering applying to FDEO for one or more Small Cities CDBG Grants for up to seven hundred fifty thousand dollars (\$750,000.00) in the Regular (Neighborhood or Housing or Commercial) Category and in the Economic Development Category for up to one million five-hundred thousand (\$1,500,000) or more. These funds must be used for one of the following purposes:

1. To benefit low-and-moderate income persons; or
2. To aid in the prevention or elimination of slums or blight; or
3. To meet other community development needs of a particular urgency because existing conditions pose a serious and immediate threat to the health or welfare of the community.
