## **BACKGROUND/RELATED STRATEGIC GOAL:**

Orjan Ahlstrom Fine Reduction Request:

This Fine Reduction Stipulation and Agreed Recommended Order involves a parcel located at 3142 & 3152 SE Hawthorn Street, Stuart, Martin County, Florida.

On June 19, 2013, an Order Finding Violation was issued by the Code Enforcement Magistrate to Orjan Ahlstrom, for the following violation(s): Section 67.201.B - Nuisance Declared: Trash, Etc, General Ordinances, Martin County Code and Section 67.201.A. - Nuisance Declared: Weeds, Undergrowth, General Ordinances, Martin County Code.

Compliance was required by July 5, 2013. On November 13, 2013, an Affidavit of Compliance/Accrued Fines was issued reflecting an outstanding fine of \$ 26,200.00 plus costs in the amount of \$575.00.

3152 SE HAWTHORNE STREET LAND TRUST is the current owner of the property. Pursuant to a Deed to Trustee recorded in Official Records Book 2666, Page 1831, Martin County, Florida Public

Records, Orjan Ahlstrom has no re	emaining intere	st in the property.	
Staff has determined that a lien reduction is warranted. Current Owners were not responsible for the violation; however, they have offered to pay \$2,677.50 to resolve the outstanding fines which have accrued.
