Proposed Project Description: The project scope includes 3,860 linear feet of 8-inch C-100 PVC Force Main, 7,395 linear feet of 8-inch C-100 HDPE force main directionally drilled, 1,040 linear feet of 8-inch C-100 HDPE force main directionally drilled at canal, and 10 linear feet of 8-inch PVC D188 gravity sewer. A lift station including a collector sump will also be constructed along Headquarters Commerce Street.

The project also includes five (5) bid alternates as follows:
1. Upsize the force main from an 8-inch dia pipe to a 10-inch dia pipe.
2. Install an additional lift station as shown within the construction documents.
